Save the Pine Barrens, Inc. and Margaret Sheehan are aggrieved by the failure to obtain enforcement of the Carver Zoning Bylaw ("Bylaw") by the Carver Building Commissioner pursuant to a written request for enforcement pursuant to G.L. c. 40A, sec. 7 (copy attached and incorporated by reference) received by him on July 1, 2021. They petition the Zoning Board of Appeals for a hearing pursuant to section 5323 of the Bylaw and for enforcement of the Bylaw. This petition is timely filed. ADM Makepeace, Inc. is violating the Bylaw by (1) it has conducted and/or is conducting earth removal activities in RA districts without Earth Removal permits; and (2) it has conducted and/or is conducting commercial mining in an RA district under the pretense that the land will be used for agriculture when in fact it is being used for industrial sand mining.
